





UNHCR data (2019)




5.5 million Palestinian refugees under UNRWA's mandate



Trump's refugee policy, in context

At most, the US will welcome 30,000 refugees in fiscal year 2019 — less than a third of the pre-Trump average.

Only 1.3 per cent of displacees were settled in 2018




The imagination dark hole: illustrative graph

Beyond Utopia as nowhere / an imaginary island (1)



- Imagined by Thomas More (1516) as an island
- οὐ ("not") and τόπος ("place")
- εὖ ("good" or "well") and τόπος ("place")
- Slavoj Žižek: "Utopia is not [a] kind of a free imagination, utopia is a matter of innermost urgency, you are forced to imagine it, it is the only way out, and this is what we need today."

Utopia as method (3) Ruth Levitas

With Levitas (2013), we see utopian thinking as 'method' building alternative scenarios in a rich, inventive way. By projecting into the future the lessons of the past the limitations of present can be starkly and honestly revealed.

"Utopia is not simply a thought experiment in a conventional sense, for it necessarily operates at the level of affect as well as intellect."

Thus, utopianism transforms statements about what is, to what could be and then what should be. Unlike the cynical realists who empty out the utopian by reducing everything to the possible and acceptable (and thence ineluctably to the likely or expedient), utopian thinking, strictly speaking, insists on including an ideal alternative, even if it appears impossible at first sight.



Visualizing the archipelago




Archipelagic theory Édouard Glissant

For Glissant, "the entire world is becoming an archipelago ... sites for understanding the complex new relations that ambivalently and chaotically join together all the hitherto unconnected parts of the world". Bongie (1999: 89)


"the insurrection of the imaginary" destroys the normativity of the nation-state. Instead, **archipelagic thinking allows us to interweave transnational threads and networks**, rhizomes and epiphytes, diasporas and epistemic communities, nodes and edges.

With the aid of an archipelagic imagination, we can usefully envision the components and connections of the transnational archipelago that will make up and continually refashion a home for the displaced (Cohen and Van Hear call this 'Refugia').




Ecotones in biology

Social Ecotone (theory) *Judith Misrahi-Barak/Thomas Lacroix*

"An ecotone is a transitional area between two or more distinct ecological communities ... A [social] ecotone indicates a place where two communities meet, at times creolizing or germinating into a new community.

"[We seek] to continue exploring the 'complex chemistry' of creolizing worlds (Robin Cohen), the 'contact zones' between cultures (Mary Louise Pratt) in contexts such as migration, diaspora, refugee movements and other postcolonial displacements and environmental evacuations."

"An ecotone offers an entry to grasp the dynamics of mutation, contact, hybridization, confrontation and their spatial and ecological implications."




